# New Statewide Action Plan to reduce drug harms

The Victorian Government has launched a Statewide Action Plan to reduce drug harms across the state. The \$95.1 million Statewide Action Plan responds to the recommendations of Ken Lay's report. The Plan also responds to recommendations of John Ryan's review of the Medically Supervised Injecting Room (MSIR).

The Plan provides more support for harm reduction services and initiatives across Victoria and in Melbourne's CBD. It does not include a second medically supervised injecting service in the CBD.

The Plan will see a \$36.4 million capital investment to establish a Community Health Hub at 244 Flinders Street, Melbourne, to open in 2026. The Hub will be operated by cohealth and will provide wraparound health and social support services and care coordination for people in the city.

The Plan will also see the appointment of Victoria's first Chief Addiction Adviser and development of a statewide alcohol and other drugs strategy.

Other key features of the plan include:

- more cohealth assertive street outreach teams across the CBD and in two new locations outside the CBD
- a Victorian-first hydromorphone trial at the Community Health Hub
- increased access to pharmacotherapy in up to 30 locations through a grants program
- a trial of Naloxone vending machines alongside needle exchange programs
- an Australian-first overdose prevention and response helpline.

# **Restrictive Interventions – online learning module available**

From 1 April 2024, the use of restrictive interventions on a person receiving a mental health and wellbeing service in emergency departments (EDs) and urgent care centres (UCCs) of designated mental health services must be reported to the Chief Psychiatrist.

A new e-learn module on restrictive interventions in EDs and UCCs is now available.

#### Public Youth Mental Health and Wellbeing Service announced

The Victorian Government has announced a new dedicated public youth mental health service to be operated in partnership with Orygen.

The Parkville Youth Mental Health and Wellbeing Service will be devoted to the mental health care of young people aged 12–25 in the north-west and west of metropolitan Melbourne.

The service will continue delivering the Orygen Specialist Program (OSP) – currently delivered by the Royal Melbourne Hospital – offering targeted primary and specialist mental health care to young people with complex mental illness.

# Family Violence Multi-Agency Risk Assessment and Management Framework (MARAM Framework) in mental health and wellbeing services

The Office of the Chief Psychiatrist is interested in consulting with mental health and wellbeing service providers to gain insights into their organisational challenges and successes in implementing the MARAM Framework.

Information gathered will contribute towards the development of a Chief Psychiatrist Guideline to assist Victorian mental health and wellbeing services in the ongoing implementation and compliance with the Act.

Victoria's MARAM Framework was legislated in 2018 through an amendment of the Family Violence Protection Act 2008. MARAM training for staff of all levels, including those in leadership roles and practitioners, offers the opportunity to align practice with the framework.
